(b) Regulation (EU) No 2021/1057 of the European Parliament and of the Council of 24 June 2021 establishing the European Social Fund Plus (ESF+) and repealing Regulation (EU) No 1296/2013 (OJ. Urz. EU L 231 of 30/06/2021, pp. 21-59), hereinafter referred to "ESF+" Regulation; as

- 5) Art. 87 of the Act of April 28, 2022 on the principles of implementing tasks financed from European funds in the 2021-2027 financial perspective.
